Notification of the subpoena

The party summoning you to appear to testify must provide you with this subpoena at least 10 days before the hearing. In case of urgency, an administrative judge of the Tribunal may reduce this time period; however, this subpoena must be brought to your attention at least 12 hours before the hearing.

Witness compensation

If you are summoned to appear in a case involving matters of municipal taxation or expropriation (SAI), you may request compensation from the party summoning you.
